

1. General

The following regulations concern the dispatch of goods in case of the agreement from F-Incoterms (FCA or FOB).

2. Delivery Schedule and Transport Time

The due dates listed in the ETO delivery schedules are dates of arrival within the regular goods acceptance times at the Stockach plant. The transport time from the supplying plant to the receiving plant must be taken into account in the notification. The supplier is responsible for meeting the dates of arrival of the consignments at ETO and must therefore notify consignments for collection and make them available to the carrier in good time and correctly. Details on dispatch handling and transit times are regulated under item 3 of this Routing Order.

3. Shipping Methods and Shipping Processing

3.1. Parcel Shipping

Shipments with a maximum total **gross weight of up to 30 kg** are handled by UPS in compliance with the permissible package dimensions. The service level “**UPS Standard**” has to be selected. The notification is made via the web portal of UPS <https://www.ups.com/de/de/Home.page> with reference to ETO-ID **980 310**.

All shipments are to be dispatched without sub-pallet.

3.2. Area Freight Forwarding

Partial loads and groupage shipments are handled by the area freight forwarder. The area freight forwarder is DACHSER.

The transport quantity of the current call-off must be notified to the freight forwarder for transport by 12 noon on the day before it is made available. Notification is made exclusively via the DACHSER web-based “eLogistics” advice portal <https://elogistics.dachser.com/login/home?3> with the “targoflex” tariff. Access right to the portal can be obtained automatically via DACHSER to the e-mail address we have on file. If you have any technical questions about the eLogistics portal, please contact DACHSER directly via e-mail at dachser.steisslingen@dachser.com

For deliveries via the Dachser forwarding company, it is essential that the ETO order number is entered as a reference in Dachser's eLogistics portal.

Transport times for overseas shipments (FOB) must be coordinated with ETO Material Planning.

3.3. Time of Provision

An agreement on the pick-up time is to be made jointly and in partnership between the shipper and the forwarder. A unilateral agreement is not permitted. If nothing has been agreed on or no agreement accepted by both parties has been found, the consignment must be made available for collection for dispatch from 6 a.m. on the day of dispatch. A collection by the freight forwarder must be guaranteed by 6 p.m. This obligation to make the consignment available applies from Monday to Friday inclusive. Special pick-ups must be coordinated separately with the ETO Material Planning.
